Authorities Proving Services of Ancestor, with details

Burton Chronicles of Colonial Virginia, 1933, by Francis ^WBeaton Harrison, pp. 110, 111, 112. In 1721 Abraham Burton served on jury in Henrico Co., Va. In 1724 he was appointed by the vestry as counter of tobacco plants. In 1735, when new county of Amelia was organized, Abraham Burton was appointed road surveyor. In 1708 purchased 200 A. from Capt. Thomas Jefferson, Va. Mag. Vol. XXIII, p. 174. Land patents to him show total of 1350 A.
