

1 **James Gould #56** [CC A17-K] b. 1772 d. 3-Sep-1852

m. Mary Jane Harris #57 m. 1802 d. 1817

Won contract from US Government to build first light house on St. Simons 1807-1810.

Bought St. Clair tract about 1812 which had belonged to Major Samuel Wright. Named 'Rose Hill' tract by family and later "Rosemount" by daughter Mary. House was located in area on Dunbar creek which is now called the Enclave at Sea Palms.

Later purchased "Blackbanks" which had belonged to loyalist James Graham. Blackbanks was later deeded to his son James F. Gould. St. Clair plantation was left to daughter Mary Gould. Daughter Jamie lived in Baltimore.

2 **Mary E. H. Gould #82** [CC A17-L] b. 1809 d. 9-Apr-1872

The St. Clair Plantation was left mainly to Mary Gould, who proved to be as capable at managing the cotton fields as she was at growing roses and managing household affairs at Rosemount.

She was so devoted to the plantation that it was difficult for Horace and Deborah to persuade her to leave when the island was evacuated in 1861. After the house was burned in the Civil War she moved to New York.

2 **James F. Gould #83** b. _____

Became the owner of Blackbanks and ran the cotton plantation until the civil war. After the war he did not return to St. Simons.

When civil war was over he found the house "Rosemont" burned and in possession of a group of freemen. He managed to buy back Blackbanks which he cultivated again. Mary Gould went to live in New York. Church services were held at Blackbanks before Christ Church was rebuilt by Anson Dodge. Horace Bunch Gould's descendants mostly remained on SSI for several generations as the property was divided many times.

Mary Frances Gould was born on St. Simons Island, Georgia, but attended school at St. Mary's Hall, an Episcopal school in New Jersey. After returning to Georgia, Gould worked as a governess and a teacher, and in 1889 was accepted as a postulant by the Order of St. Katharine at Appleton Church Home in Macon.
